**STUDIO AND BILLING INFORMATION:**

**Billing** - You May Choose **Full Session**, **Half Session** or **Monthly Billing**

- All classes are based on a 9 ½ month session AUGUST 26<sup>th</sup> thru JUNE 13<sup>th</sup>. All holidays and 5 week months have been accounted for.
- **Full Session Billing** is billed to each family's DSP account by **August 26th, 2019** – which will include group dance class charges for September 2019 – June 2020 (9.5 months). This will not include solos, duets, costume, competition, convention or other misc. fees. If you choose Yearly Billing/Payment a 9% discount will be applied to account by August 26th for group class charges only. \*Must be paid by cash or check only.
- **Half Session Billing** is billed to each family's DSP by **August 26th, 2019** (5 months) and **February 1st, 2020** (4.5 months) – which will include group dance class charges for August 26th – January 31st (5 mths) and February 1st – June 15th (4.5 months). This will not include solos, duets, costume, competition, convention or other misc. fees. If you choose Half Session Billing/Payment a 4% discount will be applied to account by billing dates for group class charges only. \*Must be paid by cash or check only.
- **Monthly Billing** is billed to DSP account on the last Monday of Each Month - (AUGUST 2019 – JUNE 2020). Any open balance not paid by 10<sup>th</sup> of each month will be automatically charged to the ACH account or credit card on file on the 10th of each month.
- All Dancing Plus family and multiclass discounts will still apply and will be credited to account.
- If classes are changed or added, your payment amount will automatically be updated in your DSP account. \*The front desk must be notified of any class being dropped by the 15<sup>th</sup> of the preceding month. If notice is not received before the 15<sup>th</sup> of the month, full tuition for the next month will be due.

**Missed Classes/Cancellations**

- Missed Classes will not be credited or refunded but may be made up within three weeks of the absence. All solo and duet lessons must have 24 hours' notice of cancellation. There is a full charge for any missed lesson when sufficient notice is not given. There are no make-up classes. Tuition is non-refundable any student drops class mid-month.

**Recurring Payment Agreement** – Checking Account & Credit Card Authorization

- All Dancing Plus families will be asked to authorize regularly scheduled charges to your Bank Account (ACH), Visa or MasterCard. All balances on accounts can be paid by cash or check in the studio prior to the 10<sup>th</sup> of each month. If account monthly balance is not paid by the 10<sup>th</sup> of each month, the checking account or credit card on file will be charged the full balance on account. If ACH account or credit card payment is declined, a \$10.00 late fee per child/per week will be charged to account.
